Specific Procurement Notice N° LCS/MCA-M/ES-34/Compact

Technical Inspection Office for the Rehabilitation Works for Schools for the Secondary Education Activity

On November 30, 2015, the Government of the Kingdom of Morocco concluded a second cooperation program (Compact II) with the United States Government, represented by the Millennium Challenge Corporation (MCC), with the objective to improve the quality of human capital and land productivity.

The budget allocated by MCC to Compact II, which came into effect on June 30, 2017, amounts to 450 million dollars, to which is added a contribution of the Moroccan Government of a value equivalent to at least 15% of the American contribution. The global budget will finance, over a period of five years, two projects, namely "Education and Training for Employability" and "Land Productivity", the implementation of which has been entrusted to the Millennium Challenge Account - Morocco (Agence MCA-Morocco).

By way of this specific procurement notice, Agence MCA-Morocco requests proposals to procure the services of a **Technical Inspection Office for the Rehabilitation Works for Schools for the Secondary Education Activity** divided into 3 lots:

- Lot 1: Tangier -Tétouan -Al Hoceima region with 34 schools
- Lot 2: Region of FES -Meknes with 28 schools
- Lot 3: Marrakech -Safi region with 28 schools

The detailed description of the services to be provided is available in the terms of reference of the Request for Proposals ("RFP"), which describe the nature of the service, the tasks and obligations of the consulting firm, as well as the services to be provided. The RFP is open to all eligible Entities (Technical inspection office approved by the State) wishing to bid.

MCA-Morocco Agency will award, for each lot, a contract which will extend from the service order until the expiry of the defect liability period of the upgrading work and new construction in the institutions enrolled under this contract.

A firm will be selected in accordance with the Procurement Method for Consultants' **Least-Cost Selection** (LCS). The evaluation procedure is set out in the Letter of Invitation in accordance with the "MCC Procurement Program Guidelines" available on the MCC website. « www.mcc.gov »: https://www.mcc.gov/resources/doc/program-procurement-guidelines
