The Millennium Challenge Account-Morocco has received financing from the Millennium Challenge Corporation toward the cost of the “Education and Training for Employability and Land Employability projects”, and intends to apply part of the proceeds toward payments under the contract for the “Acquisition, Delivery, Installation and Start-up of the technical teaching equipment for vocational training institutes benefiting from the Charaka Fund financial support for the Training Institute project in the Professions of Livestock Bellota (PSC 79)” divided into 4 lots:

- **Lot 1:** Large cheese production equipment estimated at 30,764.00 USD
- **Lot 2:** Large washing material equipment estimated at 6,219.00 USD
- **Lot 3:** Large animal breastfeeding equipment estimated at 41,685.00 USD
- **Lot 4:** Large animal health care equipment estimated at 13,225.00 USD

The interested consultants may bid for one or more lots.

MCC's funding is appropriated by the U.S. Congress and obligated to the compact up-front, with no incremental or partial funding. So, when a contract is signed with an MCA Entity, money is already available to the MCA Entity and, for most contracts, invoices are paid directly to Suppliers by the US Treasury. MCA-Morocco now invites bids from eligible bidders for the acquisition of technical-educational equipment.

Bidding will be conducted through the Shopping procedures as specified in the MCC Program Procurement Guidelines (PPG), and is open to all eligible bidders as defined in the PPG.
