Specific Procurement Notice N° DP/LCS/MCA-M/EW-14/Compact

Technical Inspection Office to assist MCA-Morocco during the phases of design and carrying-out of Works for vocational training centers funded by the "CHARAKA" Fund

On November 30, 2015, the Government of the Kingdom of Morocco concluded a second cooperation program (Compact II) with the United States Government, represented by the Millennium Challenge Corporation (MCC), with the objective to improve the quality of human capital and land productivity.

The budget allocated by MCC to Compact II, which came into effect on June 30, 2017, amounts to 450 million dollars, to which is added a contribution of the Moroccan Government of a value equivalent to at least 15% of the American contribution. The global budget will finance, over a period of five years, two projects, namely "Education and Training for Employability" and "Land Productivity", the implementation of which has been entrusted to the Millennium Challenge Account - Morocco (Agence MCA-Morocco).

By way of this specific procurement notice, Agence MCA-Morocco requests proposals to provide the services of a Technical Inspection Office to assist MCA-Morocco during the phases of design and carrying-out of works for vocational training centers funded by the "CHARAKA" Fund.

divided into 4 lots:

- Lot 1: Training centers in Fes and Meknes
- Lot 2: Training centers in Tangier, Ouezzane / Bellota and Chefchaouen
- Lot 3: Training centers in Oujda, Casablanca, Beni Mellal and Had Soualem
- Lot 4: Training centers in Ouarzazate and Casablanca

The detailed description of the services to be provided is available in the terms of reference of the Request for Proposals ("RFP"), which describe the nature of the service, the tasks and obligations of the consulting firm, as well as the services to be provided. The RFP is open to **Technical Inspection firms** approved by the Central Reinsurance Company (SCR), which represents insurance companies, in order to allow the Agence to contract insurance policies, in particular for the ten-year guarantee period. If the selected **Technical Inspection firm** does not yet have the approval, it must be accepted by the Moroccan insurance companies before signing the contract with the Agence MCA-Morocco.

The MCA-Morocco Agency will award for each lot, a contract that will commit the contractor for a period of forty **(40) months.**

A firm will be selected in accordance with the Procurement Method for Consultants' **Least-Cost Selection** (LCS). The evaluation procedure is set out in the Letter of Invitation in accordance with the "MCC Procurement Program Guidelines" available on the MCC website: « www.mcc.gov ».
